## Revisiting Watershed Goals – Part 1

The Forum, under our previous name as the Alameda Creek Watershed Council, identified goals in five categories that address water quality. The categories are flood control and storm water quality, recreation, agriculture, natural resources and wildlife and water supply. An additional goal, public education and outreach, spans all five of these categories and is recognized as a key component of each. ***The informed participation of all watershed stakeholders is key to the success of watershed protection and enhancement efforts.***

We will be taking some time in our E-blasts to reflect on the goals for the watershed. Next month, we will focus on the first category of flood control and storm water quality. There are three focal areas under this category which are:

- Provide a quality flood protection program.
- Ensure that storm water entering creeks and San Francisco Bay is of a quality that protects and supports beneficial uses.
- Reduce and maintain erosion and sediment loads at a level that supports a healthy, naturally functioning ecosystem, including native or indigenous fish.
